NARRATIVE

At approximately 1408 hours on Saturday, May 01, 2010 Lt. Resch observed a white male running toward a pickup in the driveway of 717 Laurel Ave. The white male got into the passenger seat and the vehicle fled the residence. Lt. Resch pulled behind the silver 2005 Chevy pickup with Florida tag 766LMP which was driving West on Laurel Ave. The vehicle's registration had expired on April 12, 2010 and Lt. Resch initiated a traffic stop on the vehicle stopping it in the parking lot of Clark Citgo at 213 S. SR45A. He asked the driver and the passenger to get out of the vehicle and speak to him. He identified the driver as Joseph D. Dixon (w/m, 9/26/64). At approximately 1410 hours I arrived as his backup officer and made contact with the passenger. He provided me with his driver's license and was identified as Raymond Frank Eusden (w/m, 2/13/72). His hands where shaking as he handed me his driver's license and he had difficulty pulling out his license. While speaking with him I noticed that he was shaking slightly and having trouble sitting still. Eusden kept shifting his eyes and looking around. When I asked him where he was coming from he told me they had come from 717 Laurel Ave. I then asked him what he had gone over there for. He said that he had done some yard work for "Josh and Ryan" and was trying to collect the money "those boys" owed him. Then all in a rush he said they starting giving him a hard time about the money and then they were threatening him with bats and one of them had a gun. At this point Eusden was visibly afraid and was shaking slightly and had wrapped his arms around himself in a defensive posture. I asked Eusden and Dixon to have a seat on the curb and tell me what happened.

Dixon stated that he had picked Eusden up to take him to 717 Laurel Avenue so he could try to collect some money the residents owed him. He waited in the truck while Eusden went inside. After a very short period of time, approximately five minutes, Eusden came running out the front door with three white males behind him screaming for him to "get the fuck out" and threatening to "kick his ass."

Eusden stated that he had gone there to collect some money that the residents owed him for doing some yard work during the previous week. He said that he had known "Josh and Ryan" for a long time. When I asked who Josh and Ryan were he said their last name was Graf and that they were the brothers that live in the house at 717 Laurel Ave. He also said that he went to high school with

NARRATIVE

"the guy who got his hand blown off" and knows Ronnie Neace (w/m, 4/21/85) who hangs out a lot at that residence. When he knocked on the door today, Ryan Graf (w/m, 1/3/83) opened it and invited him in. He told Eusden to go into the bedroom and followed close behind. Once he was inside the room Neace and Joshua Graf (w/m, 2/15/84) "jumped out of the closet" and started yelling at him. Eusden saw that Neace had a club in his hand. When he asked them about the money they owed him all three started to get very close to him and threaten to "kick his ass" if he kept talking about the money. Eusden kept backing up to try and get away from the three of them; however, he ended up backed toward the closet. He stated at the time he was very afraid and knew he wasn't going to get out. Eusden felt there was no way he could get away from Ronnie Neace, Ryan Graf, and Joshua Graf. At this point Ryan started yelling, "I got a gun", "I'm gonna go get my gun", and "I'm gonna shoot you." When Ryan turned to go toward the living room Eusden pushed past the other two and made a break for the front door. As he was going out he saw that Ryan was reaching under the counter for something. Meanwhile Neace and Joshua Graf were chasing him yelling for him to "get the fuck out" and telling him they were "going to kick his ass."

Joshua Keith Graf committed the crime of false imprisonment as defined in F.S.S. 787.02(2). He was party to Eusden being directed into the room, the door being shut, and then actively surrounding and threatening him. Eusden was forcibly restrained against his will and stated that he was afraid and felt he wasn't going to get out.


Joshua Keith Graf committed the crime of aggravated assault as defined in F.S.S. 784.021. He helped to surround Eusden and threaten him once he entered the room. Through his statements and actions Eusden was put into a state of fear. These threats were made with the intent to commit false imprisonment as described above.
